CERTIFICATE FOR BULSTRAD TRAVEL PACKAGE INSURANCE POLICY



This document certifies that you, as an authorized holder of a debit card issued by EUROBANK BULGARIA AD, are insured by ZEAD BULSTRAD VIENNA INSURANCE GROUP under BULSTRAD TRAVEL PACKAGE insurance, in accordance with the conditions of group insurance policy No. 3618POSTB and the General and Special Conditions for it.

The number of your bank card is the number of your individual insurance. The cover for travel abroad is valid for an unlimited number of trips up to 92 days each, during the insurance period.

The insurance period is the same as the effective period of the contract for issuance of the respective debit/credit card.

The specified limits of liability are valid for one year during the insurance period.

The insurance is activated when the debit card is used by the cardholder for the purposes of the specific trip abroad (e.g. purchasing a flight, bus or another transport ticket, booking a hotel, renting a car or other travel-related services), and in the event of property loss or damage, the coverage is activated if the property has been purchased using the bank card.



- Medical expenses abroad as a result of an accident, with a limit of liability of EUR 30,000.
- 2. Death or permannet disability as a result of an accident abroad, with a sum insured of EUR 5,000.
- 3. Expenses for emergency dental care abroad, with a limit of liability of EUR 300.
- 4. Costs of medical transport and repatriation due to an accident, including transportation to a healthcare facility and repatriation to the Republic of Bulgaria: up to EUR 30,000, as part of the limit under it. 1.
- 5. Legal expenses abroad as a result of a traffic accident, with a limit of EUR 2,000.
- 6. Costs of vehicle repatriation as a result of a traffic accident in the Republic of Bulgaria: up to 50 km.

If you are an authorized holder of a **Mastercard World Debit card**,

Your insurance policy Covers the following risks:



- 1. Medical expenses abroad as a result of an accident, with a limit of liability of EUR 100,000.
- 2. Death or permannet disability as a result of an accident abroad, with a sum insured of EUR 5,000.
- 3. Expenses for emergency dental care abroad, with a limit of liability of EUR 300.
- 4. Costs of medical transport and repatriation due to an accident, including transportation to a healthcare facility and repatriation to the Republic of Bulgaria: up to the limit for medical expenses (it. 1) in aggregate.
- 5. Legal expenses abroad as a result of a traffic accident, with a limit of EUR 2.000.
- 6. Costs of vehicle repatriation as a result of a traffic accident in the Republic of Bulgaria: up to 50 km.
- 7. Funeral costs, in case of death as a result of an accident abroad, with a limit of liability of EUR 2,400.
- 8. Total loss of property due to theft by burglary or vandalism or total or partial damage to property due to fire, natural disasters or vandalism, if the property has been purchased with the card during the insurance period on the territory of the Republic of Bulgaria, with a limit of liability of EUR 1,750 per item and EUR 10,000 in aggregate.
- Burglary theft or loss of baggage, with limit of liability of EUR 200 in aggregate, or EUR 100 for one piece of baggage.

- 10. Flight delay, with a limit of liability of EUR 250.
- 11. Missed flight due to a connecting flight delay with, a liability limit of EUR 250.
- 12. Delay of checked-in baggage, with a limit of liability of EUR 250.
- 13. Loss of checked-in baggage, with a limit of EUR 1,000.
- 14. Costs of an organized trip of a family member to attend the insured person during hospitalization abroad: EUR 80 per day, but not more than 5 days.

in order to notify the coordinators, in Bulgarian or in English, about the occurrence and the kind of assistance you need. If you are unable to call personally, this can be done by a family member or close person, lawyer, medical professional, or by the medical facility where you are receiving assistance.

Please make sure to provide your full name, personal identification number and a telephone number for contact.

- Be prepared to provide the information requested by the Assistance Company (bank card number, information about the occurrence, etc.)
- Please keep all original copies of documents certifying to the event, including but not only:
- Report for lost checked baggage issued by the airline (in case of delayed or lost checked baggage);
- Regular flight ticket;
- Written confirmation about the flight delay from the air carrier or other evidence attesting to the occurrence of the event;
- Medical documents; prescriptions, invoices, and receipts showing the type and amount of medical expenses incurred;

- Documents certifying the circumstances and causes of the insured event, issued by the competent local authorities (police, court, hospital, etc.), depending on the type of event.
